After years of discussion, in December of 2020, the City of Los Angeles disassembled and moved a 1941 Streamline Moderne Texaco station, located at 1650 Silver Lake Boulevard, to an unidentified location until a new site could be identified. What remains is a patch of land cluttered with graffiti and trash. On a block that features fine restaurants and upscale shops, this eyesore is what people see when they enter Silver Lake.

Residents and business owners have repeatedly asked the city to provide appropriate trash receptacles and remove the graffiti, but so far the requests have been ignored.

## Latest Silver Lake Crime Report

Silver Lake's acting senior lead officer, Jose Ramirez, reports a range of criminal activity took place in the community **from August 8 until September 14**, including a homicide on Sunset Drive and 17 cases of grand theft auto. SLO Ramirez stated that while Silver Lake is one of the safest neighborhoods in LAPD's Northeast Division, every citizen should hide valuables that are visible in their cars, garages, etc.

Report highlights include:

- Homicide on Sunset Drive
- Rapes, robberies and assaults—none reported
- Shots fired at Waterloo and Duane
- Burglaries—two on Sunset Boulevard, two in the 3100 block of Griffith Park
- 17 grand theft auto (mostly on Silver Lake Boulevard)
- 20 burglaries from motor vehicles (mostly on Easterly Street north of Sunset)
- Stolen recovered vehicle (2600 Block of Corralitas Drive)
- No violent crimes
- No property crimes

## CD 13 Councilmember Mitch O'Farrell on the Need for True Compassion



Yesterday, Councilmember O'Farrell wrote that there is nothing compassionate about enabling unhoused individuals to live or die in squalor on city sidewalks. And according to *The Eastsider*, he also introduced a resolution that would enforce the [city's new anti-camping ordinance](#) within 500 feet of 17 CD 13 locations, from Echo Park and Silver Lake underpasses to the Barnsdall Art Park.

City staff and outreach workers have previously offered unhoused residents shelter, housing, services, meals numerous times at these locations, said O'Farrell. "People experiencing homelessness belong indoors in safe, secure, managed environments. There is nothing compassionate about enabling unhoused individuals to live or die in squalor on city sidewalks."

## Video Tells Story of Silver Lake's Pioneer Asian Architect Eugene Kinn Choy

According to the National Council of Architectural Registration Boards, fewer than one in five new architects identify as racial or ethnic minorities, and approximately two in five are women. **Silver Lake's Eugene Kinn Choy** was the second Chinese-American to become a member of the American Institute of Architects and overcame unimaginable obstacles to become one of America's foremost architects. He was the first Chinese-American graduate of the USC School of Architecture (1939) and founded a successful firm inherited by his sons.

Every decade, city council district boundaries are redrawn based on the U.S. census. The Los Angeles City Council Redistricting Commission is tasked with this chore and seeking your input. The new boundaries will determine who represents Silver Lake and other communities in Los Angeles.

The Commission will only be accepting publicly hand-drawn maps, online maps from Districtr, and written statements on communities of interest (COI) until 5:00 p.m. on Friday, September 17, 2021.
